Applications for Membership: We received two Applications for Membership -

Portland Jr. Winterhawks - Application for Membership was approved. The residential draw zone is the State of Oregon.

Puget Sound Ice-sports Association - Application for Membership was approved. The residential draw zone is the State of Washington.

- PCAHA Executive Committee Members of the 2024-2025 PCAHA Executive Committee 5. were elected or ratified.
- 6. **PCAHA Special Awards** During the AGM the recipients of the PCAHA Special Awards for 2023-2024 were recognized.

BC Hockey Resolutions:

A review was conducted of the Resolutions for the upcoming BC Hockey Annual Congress (June 7-9, 2024). There are 6 Resolutions -

- 1. Change in term from 2 years to 3 years for Board of Directors. This would mean an Executive member would max out at 9 years instead of the current 8 years. Reasoning was ensuring consistency and mentorship **Concurrence**
- 2. Changing the number of players on U13, U15 and U18 teams to 20 players registered on January 10 no resolution is required. This is under Important Dates Concurrence
- New By-law 605 Allow the CEO to make housekeeping changes that don't affect intent, correcting typos, inconsistencies such as ensuring everything current regarding division names etc. Concurrence
 - 4. Reg. 3.7 All team Officials must obtain Respect in Sport prior to any team participation in practices and games **Concurrence**
 - 5. Reg. 3.3 All non-carded team coaches below U11 (U7 & U9) are required to meet the following minimum standards. Attend Coach 1 level clinic by Dec. 15 of the current season or have achieved a Coach 2 Coach level trained status from 2008-09 to 2016-17 Concurrence

6. To revise By-law 211 so it aligns with a change made to Hockey Canada By-laws 10.2 and 10.3 requiring permission for any local association/district by-law or regulation which is different than either BC Hockey or Hockey Canada. There are two options
